

# PROVISIONS SPECIFIC TO .XN--TCKWE (.XN--TCKWE) REGISTRATIONS

VeriSign, Inc. (“Registry Operator”) is the registry operator for the .XN--TCKWE (.xn--tckwe) TLD.

## GENERAL PROVISIONS

*Non-Uniform Renewal Pricing.* You acknowledge and agree that the TLD will have non-uniform renewal pricing, such that the renewal fee for certain domain names in the TLD may be higher than the renewal fee for other Domain Names in the Registry TLD.

*Prohibited Activities.* You are prohibited against distributing malware, abusively operating botnets, phishing, pharming, piracy, trademark or copyright infringement, fraudulent or deceptive practices, counterfeiting or otherwise engaging in activity contrary to applicable law. Consequences for such activities include suspension of the registration of your domain name(s).

*Registry Policies.* You agree to comply with all Registry Policies as published on the [Registry Operator website](#) or as otherwise made available by Registry Operator.

*Registry Operator’s Reservation of Rights.* You acknowledge and agree that Registry Operator reserves the right to delay, deny, delete, freeze, cancel, or transfer any domain name registration(s) or transaction(s), place any domain name(s) on registry lock, hold, suspension, or similar status, and take such other action, in each case as Registry Operator deems necessary in its unlimited and sole discretion, (A) to the extent required: (1) to correct any domain name registration mistakes made by Registry Operator or the registrar; (2) to protect against imminent and substantial threats to the security and stability of the Verisign SRS; (3) pursuant to any legal order or subpoena of any government, or administrative or governmental authority, or court of competent jurisdiction, or as otherwise specified for one or more Registry Operator TLDs; (4) to respond to a report from ICANN pursuant to Section 6.3 of Specification 6 (Name Collision Report Handling) of the [Registry Agreement](#), as determined by Registry Operator; and/or (5) to comply with specifications adopted by any industry group generally recognized as authoritative with respect to the Internet (e.g., RFCs), (B) in the event you breach any of the provisions these terms or the Agreement, and/or (C) in the event the TMCH reports fraud in an SMD File.

*Indemnification.* You agree to (A) indemnify, defend, and hold harmless Registry Operator and its affiliates, and each of their directors, officers, employees, contractors, agents, successors and assigns, from and against any and all claims, damages, liabilities, costs and expenses, including without limitation, reasonable legal fees and expenses, arising out of or relating to, for any reason whatsoever, your domain name registration(s), including without limitation, your use of any or all of your domain names; and (B) not enter into any settlement or compromise of any such indemnifiable claims, damages, liabilities, costs and expenses without Registry Operator’s prior written consent, which consent shall not be unreasonably withheld;

*Data.* You agree that Registry Operator may collect, use, store, access, transfer, publish, disclose and process your personal data and data related to your domain names. You release Registry Operator from any and all claims, damages, liability, costs and expenses due to Registry Operator’s collection, use, storage, access, transfer, disclosure and/or processing of such data.

*Technical Analysis.* You acknowledge and agree that Registry Operator may periodically conduct technical analysis to assess whether your domain names are being used to perpetrate security threats, such as pharming, phishing, malware, and botnets.

*Lawful Purposes.* You agree to register and use all your domain names applied for, or registered to you, only for lawful purposes.

*Eligibility Requirements.* You affirm that you meet the sunrise eligibility requirements established by ICANN and/or Registry Operator for the TLD for any domain name(s) registered.

*Compliance.* You agree to comply with all of the following related to any domain name registration(s): (A) any law or regulation or any rule, order, directive, or subpoena of any government, administrative or governmental authority, or court of competent jurisdiction; and (B) any intellectual property rights or other third party right;

*Third-Party Beneficiaries.* You agree that Registry Operator and its affiliates, and each of their directors, officers, employees, contractors, agents, successors and assigns are intended third-party beneficiaries of the Agreement;

*Survival.* You agree that these provisions and terms shall survive the termination or expiration of the Agreement.
